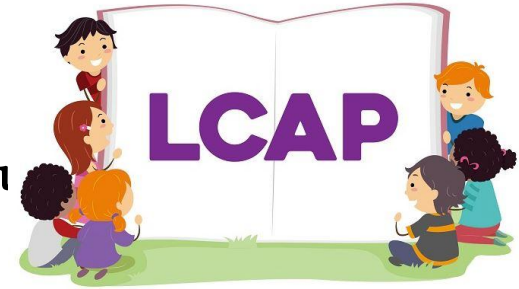

# What is the Local Control Accountability Plan?

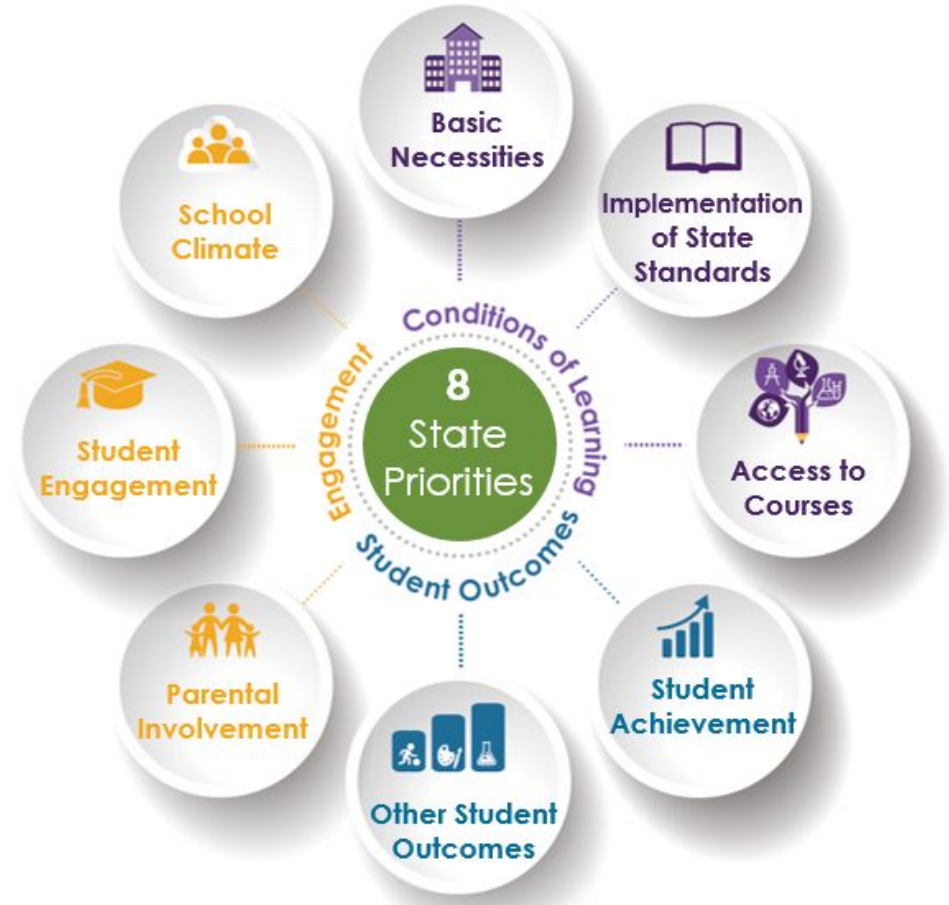
- Part of the **Local Control Funding Formula (LCFF)**.
- Describe the **District's overall vision for students, annual goals and specific actions.**
- Must focus on **eight areas identified as state priorities.**
- **Aligned to the District's budget** to help achieve the goals, and assess each year how well the strategies in the plan were able to improve student outcomes.
- District **must engage parents, educators, employees and the community** to establish these plans.



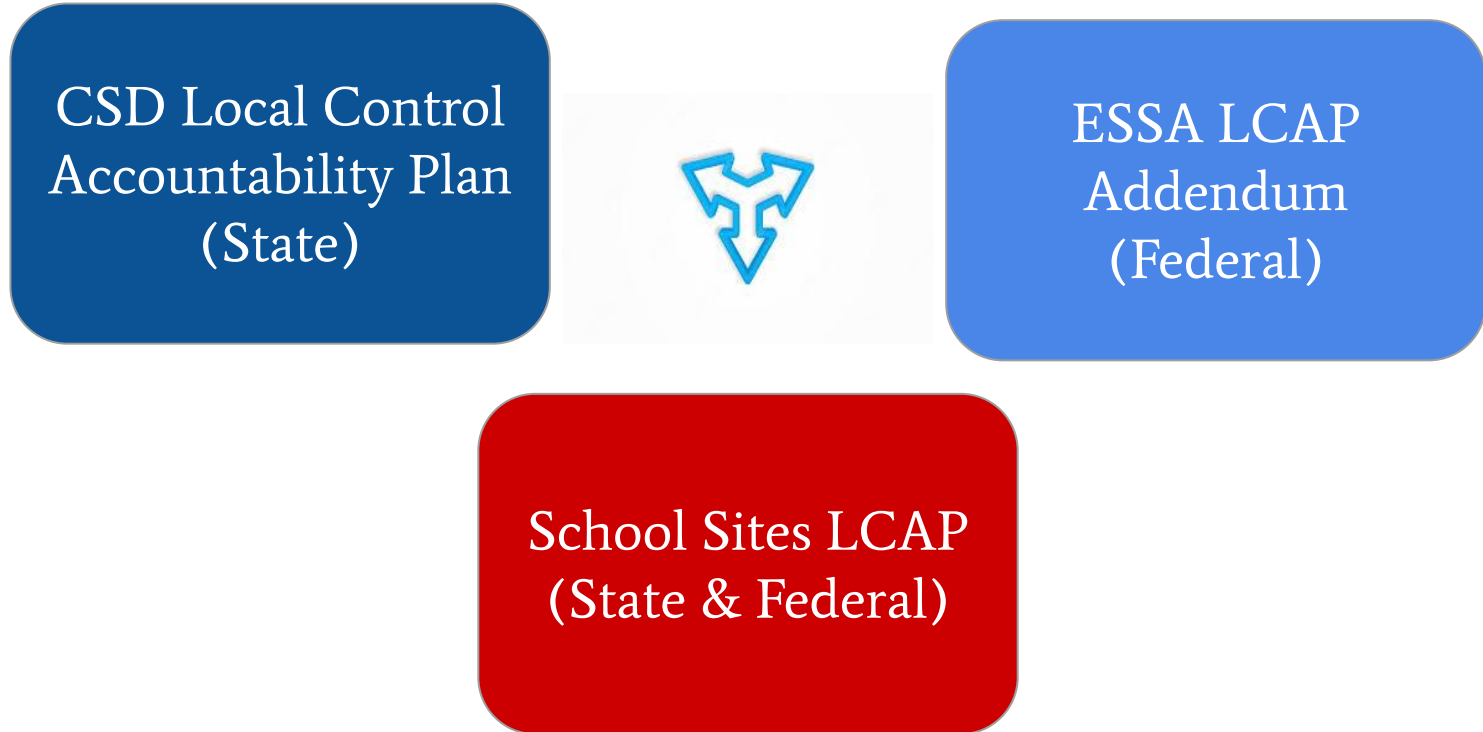
# 8 State Priorities

Each school district's LCAP must focus on eight priority areas that help all students succeed. These eight priority areas reflect the belief that many factors – both inside and outside the classroom – positively impact student success.

These eight priorities are grouped under three categories - **Conditions of Learning**, **Student Outcomes** and **Engagement**.

# Educational Partners Engagement Process

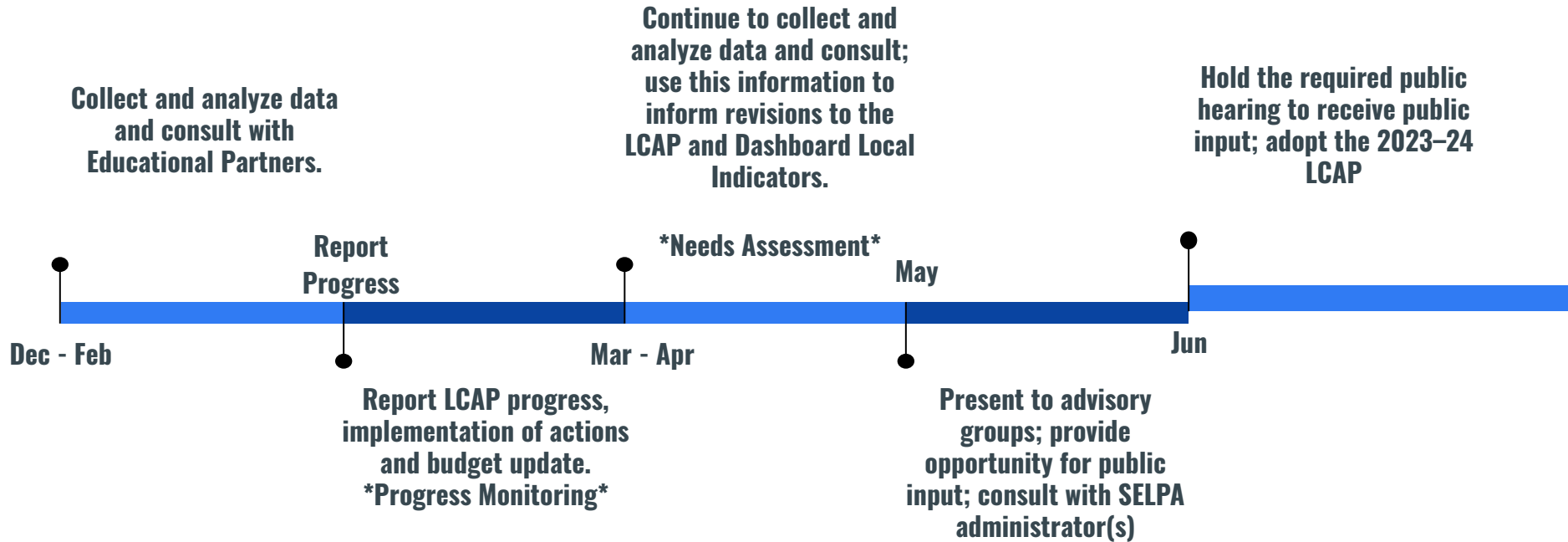

# CSD's Educational Partners Engagement Process Summary

Cambrian and its educational partners had a variety of opportunities to engage, provide input and participated in the decision-making process in the development of the LCAP throughout the year. Using our existing district's and schools' committees, which included the Instructional Leadership Council, the District LCAP Advisory Committee, the District English Learner Advisory Committee, the Curriculum Instruction Assessment Council. LCAP data and updates were also provided during these meetings and events throughout the year, including Board. These opportunities allowed for our educational partners to engaged in deeper discussions, clarifications, to provide input and ideas for improvement.



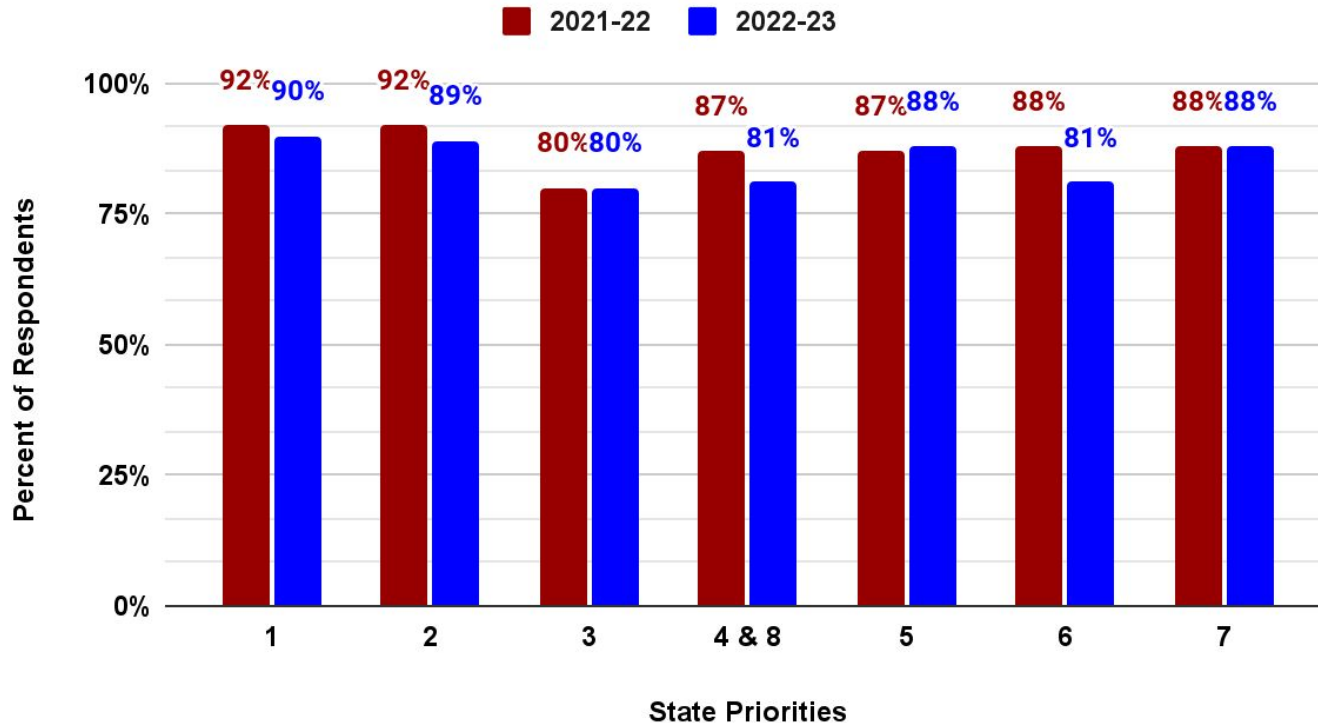
The district and schools also surveyed students, all staff and parents to get input on what's working well and where we can improve using a variety of input tools. All of the information gathered from these engagement opportunities were examined to inform the development of the LCAP goals and actions for the 2023-24 school year. # Rank the top three most important actions, services, and/or resources in addressing the 8 State Priorities for the 2023-24 LCAP

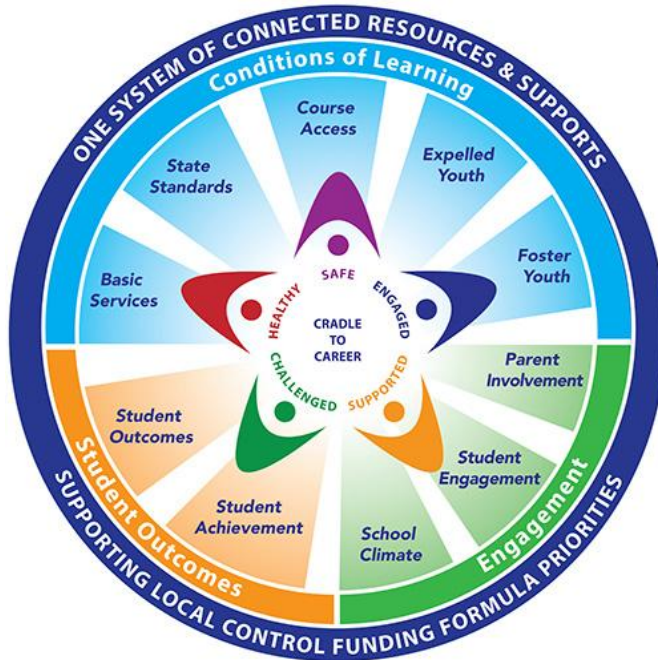
In consultations and getting input from our educational partners, including LCAP advisory Committee, staff committees, District English Learner Advisory Committee (DELAC), and students, as well as input from community input surveys throughout the year, we asked our partners to rank in order the top three most important actions, services, and resources in addressing the 8 State Priorities when developing the district Local Control Accountability Plan.

The following slides is a summary of the top 3 actions and services as they relate to the 8 State Priorities for developing the 2023-24 LCAP.



# Top three most important actions, services, and/or resources in addressing the 8 State Priorities for the 2023-24 LCAP

## Priority 1



1. Recruit and provide ongoing support and training to retain highly qualified teachers in all subject areas. (82.9%) - LCAP Goal 2
2. Maintain school facilities, including libraries, fitness equipment and playgrounds, to ensure they are in good working order. (64.7%) - LCAP Goal 3
3. Ensure that all students have access to current textbooks and relevant materials aligned to the standards. (53.1%) - LCAP Goal 1

# Top three most important actions, services, and/or resources in addressing the 8 State Priorities for the 2023-24 LCAP

## Priority 2

1. Provide ongoing teacher and support staff professional development in the state standards and their effective application in the classroom. (77%) - LCAP Goal 2
2. Ensure that the state standards complement and/or enhance the teaching and learning in the classrooms. (67.5%) - LCAP Goal 1 & 2
3. Provide specialized professional development on the state standards for teachers and support of English learners, students with special needs, and other significant student populations. (63.5%) - LCAP Goal 2

## Priority 3

1. Provide a variety and numerous opportunities for parent education/workshops & information events, including events in different home languages. (71.2%) - LCAP Goal 4
2. Provide regular and accessible communication (e.g., automated phone calls, text messaging, electronic school/district newsletters, website, etc.) (62.6%) - LCAP Goal 4
3. Enhance and/or create school and community services and support (e.g., home/school liaison, translation services, etc.) (58.9%) - LCAP Goal 3 & 4

# Top three most important actions, services, and/or resources in addressing the 8 State Priorities for the 2023-24 LCAP

## Priority 4 & 8

1. Provide and ensure extended/additional learning time is accessible to all students needing additional support (e.g., including high dosage tutoring, before, during and after school intensive interventions and support) (65.6%) - LCAP Goal 1
2. Provide professional development and support for all staff on research-based best instructional practices to improve and/or boost student outcomes. (56.7%) - LCAP Goal 2
3. Provide teachers and administrators structured collaboration time for high-quality assessment and progress monitoring to improve student outcomes.(53.7%) - LCAP Goal 2

## Priority 5

1. Increase opportunities for students to participate in extracurricular activities offerings (e.g., student clubs, sports, visual and performing arts, etc.) (79.4%) - LCAP Goal 1
2. Address and measure student wellness, including mental and physical health, and its impact on attendance and learning. (71.8%) - LCAP Goal 3
3. Increase, improve, and/or expand current and new learning and enrichment opportunities before and after school, and during intersessions (71.2%) - LCAP Goals 1 & 3



# Top three most important actions, services, and/or resources in addressing the 8 State Priorities for the 2023-24 LCAP

## Priority 6

1. Improve and/or provide more social and emotional learning opportunities for students (recognizing and managing emotions, caring about others, making good decisions, developing positive relationships) (60.4%) - LCAP Goal 3
2. Address mental health services and support (e.g, counseling services at all sites, behavior therapists to support general education, school psychologists support, etc.) (54.3%) - LCAP Goal 3
3. Ensure a safe school environment for emotional, social and physical well-being. (e.g., by including school nurse; addressing internet and social media safety) (53.1%) - LCAP Goal 1, 3, & 4

## Priority 7

1. Provide all students access to specialized programs (e.g., art, music, PLTW, World Languages, etc.) (88.7%) - LCAP Goal 1
2. Ensure that all students have access to a broad course of study.(76.4%) - LCAP Goal 1
3. Provide and/or improve programs and services in core subject areas for students with greater needs such as low-income students, English Language Learners and foster/homeless youth. (62.9%) - LCAP Goal 1

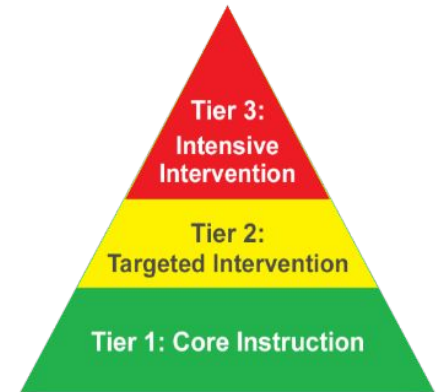

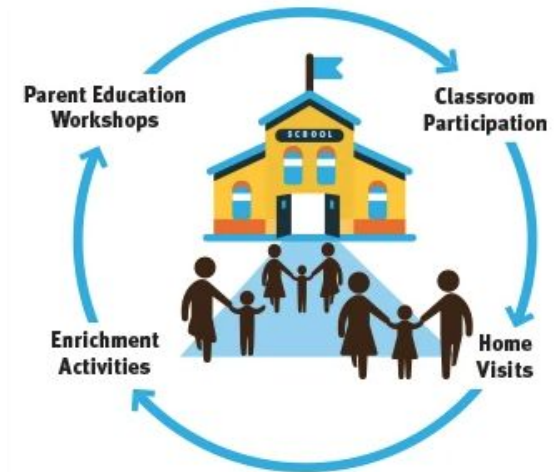

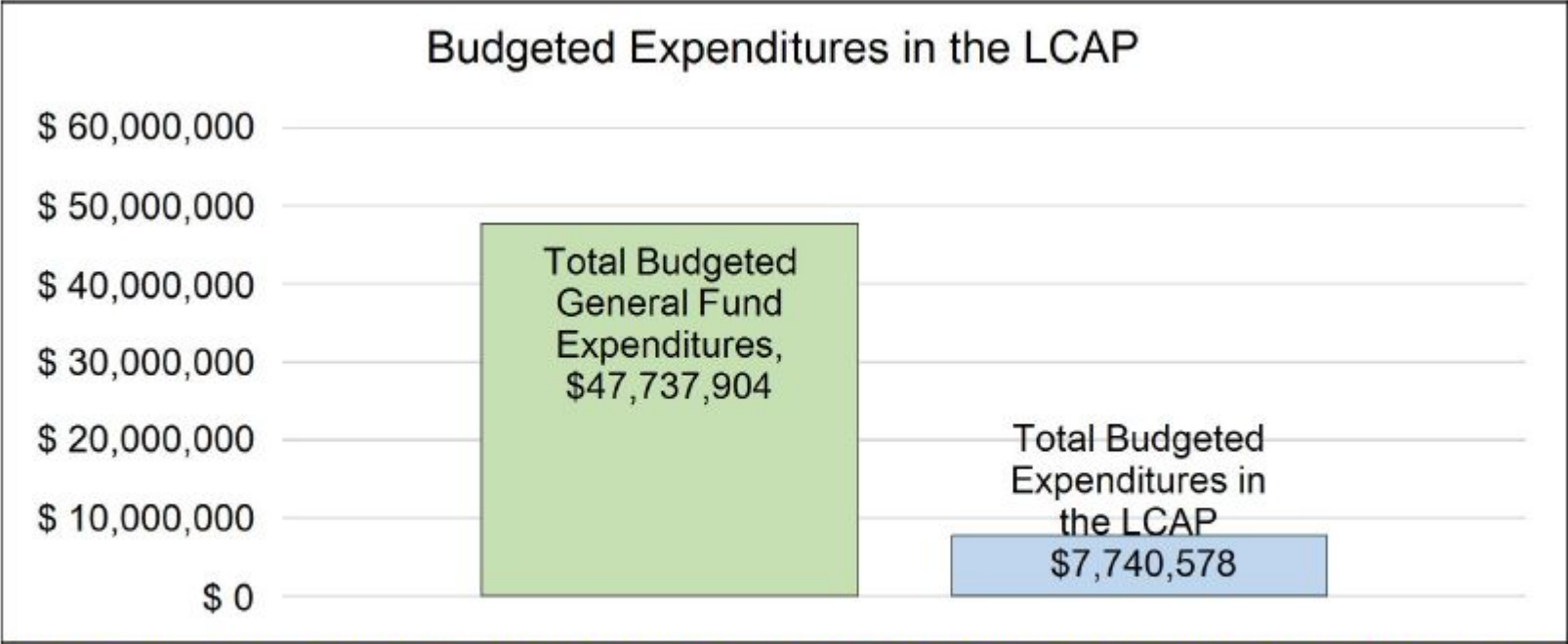
