9. PUBLIC COMMENTS

Kim Stevenson and Kamialjit Sangha, Cambrian District Teachers Association Co-presidents, shared an update with the Board on what is transpiring in the Cambrian Teacher community. They presented documents with compiled data on teacher salaries in neighboring district and encouraged the Board to make Cambrian teachers' a priority and invest in teachers which is investing in students.

10. INFORMATION AND STUDY ITEMS

10.1 Communication Plan Update 2021-22:

Mrs. Dawn Klavon, Coordinator of Marketing, Communication, and Community Engagement, gave an overview of Cambrian's Communication Plan and accomplishments for the 2021-22 school year. She shared how the District and school sites celebrate student success and the different ways Cambrian families are kept informed on what is transpiring in the Cambrian School Community.

10.2 <u>Measure R: Award General Trades Contract for the HVAC Project at Farnham and Sartorette Schools</u>: Rick Kramer from RGM Kramer Inc., presented the General Trades Contract for Beals Martin to replace the aging HVAC systems at Farnham and Sartorette Schools.

ACTION: On a motion by Mr. Scofield, seconded by Mrs. Gillis, the Board awarded the General Trades Contract for the HVAC Project to Beals Martin based on their low bid in the amount of \$1,526,957. Motion **CARRIED** 5-0

10.6 <u>Measure R: Inspector of Record Services for Bagby, Fammatre, Farnham, Price, and Sartorette</u>: Cambrian wishes to enter into agreement with Construction Inspection Services Inc. to ensure the alterations to buildings, classrooms, fire alarm upgrades, and the HVAC replacements comply with building codes, ordinances, regulations, and contract specifications.
