10. INFORMATION AND STUDY ITEM

10.1 <u>Appointment of Administrative Position: Coordinator of Student Support Services</u>: Superintendent Schwiebert had the honor of introducing Mrs. Julie Orlando as the new Coordinator of Student Support Services. Mrs. Orlando has been an integral part of Price Middle School for the past two years, and her extensive experience in Student Services makes her an outstanding choice for this important role.

- 10.2 <u>Health and Wellness: Child Nutrition Program Update for 2024-25</u>: Mrs. Maria Escobar, Sodexo representative, along with Ms. Deborah Gil, Food Services Supervisor, provided an update on the District's Food Service program. They presented a five-year comparison of meal counts and shared ongoing efforts to increase scratch-made meals. The team also highlighted new kitchen equipment acquired through grant funding, recent events, and outlined updates to current food service regulations.
- 10.3 <u>Curriculum & Instruction: Instructional Specialists Update</u>: Debbie Clima, Christine Katz, Andrea Pickering, Chrissy Terwilliger, and Emily White, Cambrian's Instructional Specialists team, provided an overview of their roles and responsibilities. They highlighted some of their focal areas that provide specialized instructional support to principals, teachers, and students.
- 10.4 <u>Technology: Incorporating Artificial Intelligence (AI) into Teaching and Learning Progress Update</u>: Mr. Matt Hill, Director of Educational Technology, provided an update on the district's efforts to integrate Artificial Intelligence (AI) into teaching and learning.
- 10.5 <u>Curriculum & Instruction: Universal Screening for Reading Difficulties Senate Bill 114</u>: Assistant Superintendent, Mr. Linh Nguyen, provided an overview of Senate Bill 114, which requires universal screening

for reading difficulties, including dyslexia, for students in kindergarten through second grade beginning in the 2025–26 school year. The presentation detailed Cambrian School District's process for selecting a state-approved screening tool aligned with the Multi-Tiered System of Supports (MTSS), including a comparison of leading options and the district's recommendation of UCSF Multitudes. It also outlined the district's phased implementation plan, highlighting key components such as professional development.

ACTION: On a motion by Trustee Gillis, seconded by Trustee Erickson, the Board adopted the UCSF Multitudes Reading Difficulties Risk Screener for Grades K-2, as required by Senate Bill 114. Motion **CARRIED** 5-0
