# Transportation Plan (New Requirement)

In accordance with Education Code 39800.1 (July 10, 2023), the District shall develop a plan describing the transportation services it will offer to its pupils and how it will prioritize planned services for pupils in transitional kindergarten, kindergarten, and any of grades 1 to 6, inclusive, and pupils who are low income.

**The plan shall be adopted by the local educational agency governing board on or before April 1, 2023, and updated by April 1, each year thereafter.**

<b>Who Receives Transportation Services</b>	The District provides transportation to pupils with disabilities (as outlined in IEP) and homeless and foster youth students at no-cost.

# Information - Transportation Funding

<b>2013-2014</b>	<p>In the enactment of the Local Control Funding Formula (LCFF), State funding for Home to School Transportation was established at a fixed amount, in perpetuity, based on the amount of funding each district received in 2012-13 for General Education and Special Education transportation.</p> <p>This was accomplished by providing an “add-on” to the LCCF funding. For Cambrian School District this fixed amount is <b>\$159,032</b>.</p>
<b>2022-2023</b>	<p>The State Budget allows districts to receive the greater of the current Transportation add-on augmented for Cost-of-Living adjustment (COLA) or 60% of reported transportation costs.</p>
