- 7.1 Mr. Scofield announced that Friday, October 30 is a professional development day for Cambrian teachers and students do not have school. Dr. Andrews acknowledged how challenging the past 10 weeks of school has been. The District is continuously problem solving to better support students, staff, and families. She encouraged families to make the decision to opt in, either, our Virtual School Program or our Distance Learning Program (returning to in-person when deemed feasible) based on what is best for their family needs. Dr. Andrews asked the community to continue to work together to support our students the best way possible given the current pandemic.

Budget & Fiscal

Stability Plan

8.1 Budget and Fiscal Stability Plan: Review:

Chief Financial Officer, Ms. Penny Timboe, provided an update on Cambrian's current budget outlook. She reviewed the Fiscal Stability Plan process over the past several years and the Governor's Budget Proposal due to the Global Pandemic. Ms. Timboe recapped the changes to the multi-year projections and shared that in order to mitigate the cash flow state deferrals the District secured a loan ("TRAN") to meet Cambrian's financial obligations for the 2020-21 year.

The Board had an opportunity to review and discuss the Fiscal Stability Plan reductions approved with the 2020-21 Budget Adoption and agreed to continue to review the Fiscal Stability Plan given the changing economic factors with the District budget.

8.2 <u>Update and Next Steps: In-Person Learning and Instruction 2020-21:</u>

Dr. Andrews reviewed Cambrian's approach to in-person instruction plan approved by the Board on July 14, 2020. She highlighted the steps completed in Phase 1 and provided an update on the current process of Phase 2. Ms. Penny Timboe, Chief Financial Officer, shared the progress on the safety measures for Cambrian's facilities and all the personal protective equipment Cambrian will be providing for staff and students. Mr. Nguyen, Assistant Superintendent of Educational Services, highlighted the key comparisons in regards to the recent district wide survey for staff and families conducted on September 30, 2020.

Dr. Andrews proposed an adjusted timeline for gradual return to in-person instruction for elementary schools given the changes in Santa Clara County:

- January 11: Transitional Kindergarten through Grade 2
- January 19: Grades 3 through 5
- 6 through 8 grades return date will be determined at a future Board meeting.

The Governing Board, Dr. Andrews, and staff, had the opportunity to continue the discussion regarding the next steps to support students returning to our campuses. A tentative special Board meeting is scheduled for January 7, 2021, which will allow Cambrian School District to continue to monitor the conditions in Santa Clara County for a safe return to in-person instruction.

Melanie Blackard, Cambrian Parent, encouraged the Board to work collaboratively with families and resurvey the community on their thoughts and input.

Kerri Lauck, Cambrian Teacher, asked the Board to put the health and wellbeing of students and staff first.

Catherine Winfield, Cambrian Parent, thanked the Board for the possible delay in starting students in person in January 2021 and asked that student grade levels be brought back more slowly.

Karen Ghilarducci, Cambrian Special Education Teacher, urged the Board to reconsider bringing students back to campus for the protection of teachers and students.

Jose Maria Caro, Cambrian Parent, questioned the Board in regards to the safety of the out dated HVAC systems.

Moema LeBlanc, Cambrian Parent, asked the Board to focus on the students who are struggling and bring them back to in-person learning as soon as it is safe.

Erin Ryan, Cambrian Parent, encouraged the Board to continue to involve families with the steps taken to ensure the campuses are safe for students to return.

Heather Olah, Fammatre Parent, asked for updates that are more specific on the progress of ensuring the HVAC systems meet the new safety standards.

Todd Nelson, Cambrian Parent, urged the Board to delay bringing students back to campus for the safety of the teachers.

Melissa Wuenschel, Cambrian Parent, asked the Board to commit to keeping families informed regarding the updating of the HVAC systems.

Stacey Patrick, Cambrian Teacher, voiced her concern with all the moving parts to open classrooms safely and urged the Board to consider the community's request to be part of the solution.

Dusta Eisenman, Cambrian Parent, encouraged the Board to reopen campuses for families who are ready to have in-person instruction for the students.

Melissa Ojczyk, Cambrian Parent, shared that families want students to back to school in safest way possible way and urged the Board to consider the mental health of the students, staff, and families.

Jessica Elix, Sartorette Parent, voiced her thoughts on asynchronous learning days and shared that students are spending too much time on the computer.
