11. INFORMATION AND STUDY ITEM

11.1 <u>Resolution 22-23-12: Declaring The Futility of Public Bidding for Abatement Trade Services for Phase 1</u>
<u>Modernizations at Bagby, Fammatre, and Price Schools</u>: Cheryl Demeyer from RGM Kramer, presented the resolution. The resolution will allow the District to continue with PARC Specialty Contractors to complete

the current project in process with the 30.14% increase over the original contracted amount due to the associated labor costs to meet the school start deadline from the discovered asbestos putty around windows and the removal and replacement of sheetrock.

ACTION: On a motion by Mrs. Presunka, seconded by Mr. Middleton, the Board approved Resolution 22-23-12 and allow Cambrian to continue working with PARC Specialty Contractors and complete the HVAC Abatement Trade Services for Phase 1 Modernizations at Bagby, Fammatre, and Price Schools. Motion **CARRIED 4-0**

11.2 Measure R: Change Orders 1J, 3I, 4F, 5H, 6G, 9E, and 10A - Phase 1 Modernization Projects: Cheryl Demeyer from RGM Kramer Inc., presented the change orders in connection with the Phase 1 Modernization Project to replace the aging HVAC systems at Bagby, Fammatre, Farnham, Sartorette, and Price Middle School.

ACTION: On a motion by Mr. Middleton, seconded by Mrs. Erickson, the Board ratified the seven (7) necessary change orders 1J, 3I, 4F, 5H, 6G, 9E, and 10A, in connection with the Phase 1 Modernization Projects. Motion **CARRIED 5-0**

- 11.3 <u>Governor's Budget Proposal (January 2023)</u>: Dr. John Pappalardo Chief Financial Officer, provided a summary of the Governor's Budget Proposal for the 2023-24 State Budget. The Governor's revenue forecast assumes slower economic growth over the next couple of years with some highlights below:
 - The Governor continues to prioritize implementation of universal transitional kindergarten
 - CalSTRS projects an employer contribution rate of 19.10% for the next several years
 - CalPERS, the employer contribution rate for 2023 -24 would increase from the current rate of 25.37% to 27.00%
- Resolution 22-23-16: Observance of Holiday on Alternate Date: Superintendent Schwiebert presented Resolution 22-23-16: Observance of a Holiday on an Alternate Date. Ed Code 37220 (e) allows the Governing Board the option of celebrating Lincoln's Birth Day on an alternate date. The resolution recommends the observance of Lincoln's birthday to be Friday, February 23, 2024, instead of the state accepted date of Monday, February 12, 2024.

ACTION: On a motion by Mrs. Presunka, seconded by Mr. Villalobos, the Board approved Resolution 22-23-16: Observance of a Holiday on an Alternate Date. Motion **CARRIED 5-0**

11.5 Proposed 2023-24 School Year Calendar: Superintendent Schwiebert presented the proposed the 2023-24 school year calendar. The calendar reflects one hundred eighty (180) student days and one hundred eighty-five (185) teacher work days and one (1) additional day for new teachers. In developing the calendar options, consideration was given to aligning the calendars to the neighboring elementary and high school districts as much as possible. The calendar was reviewed by representatives from both the Cambrian District Teachers' Association and the California State Employees' Association with a positive response of approval.
