9. INFORMATION AND STUDY ITEM

9.1 <u>Personnel: Approval of Administrative Position - Steindorf Principal</u>: Superintendent Schwiebert had the pleasure to recommend Ms. Trisha Lee for the role as Steindorf STEAM School's Principal. Ms. Lee comes to us with a wealth of experience and passion and will be a huge asset to our students, staff and district.

ACTION: On a motion by Trustee Middleton, seconded by Trustee Erickson, the Board approved the hiring of Ms. Trisha Lee as the new principal at Steindorf STEAM School. Motion **CARRIED** 4-0

9.2 <u>Measure H: Resolution 23-24-11: Election to Continue Measure H Parcel Tax</u>: Superintendent Schwiebert presented Resolution 23-24-11. The Approved resolution will allow Cambrian to place the continuation of Measure H on the November 5th ballot.

- 9.4 <u>Health and Wellness: Award Contract for Food Service Consulting and Purchasing</u>: Chief Financial Officer, Dr. John Pappalardo, summarized the bid process for the Food Service Consulting and Purchasing Contract held on Monday, June 17, 2024. Cambrian received one bid from Sodexo.
 - Contract Term: Maximum of five years with approved annual renewals

ACTION: On a motion by Trustee Middleton, seconded by Trustee Villalobos, the Board awarded the Contract for Food Service Consulting and Purchasing to Sodexo for the 2024-25 school year with an option to renew the contract annually for the next 4 years. Motion **CARRIED** 4-0

9.5 <u>Educational Services: 2023-24 California Dashboard Local Indicators Update</u>: Mr. Linh Nguyen, Assistant Superintendent of Educational Services, provided a summary on the California School Dashboard Local Indicators. He gave a quick overview of the Dashboard's purpose, State Priorities, and shared how Cambrian is continuing to meet the State's priority areas.

9.8 <u>Personnel: Injury and Illness Prevention Program</u>: Assistant Superintendent of Personnel Services, Mrs. Natalie Gioco, shared an overview of the Injury and Illness Prevention Program (IIPP). The plan ensures our practices are consistent and easily accessed by employees. The plan includes; Workplace Violence in California; Bloodborne Pathogens Exposure Control Plan; Ergonomics Injury and Illness Prevention Plan; Heat Illness Prevention; and will be reviewed and approved annually by the Board.

Superintendent Schwiebert presented the Tentative Agreement between the Cambrian District Teachers'
Association and the Cambrian School District.

ACTION: On a motion by Trustee Erickson, seconded by Trustee Villalobos, the Board approved the AB 1200 Disclosure of Collective Bargaining Agreements and the tentative agreement between Cambrian District Teachers' Association and the Cambrian School District through June 30, 2026. 9.10 Personnel: Agreement between the California School Employees Association, Local 641, and the Cambrian School District: Superintendent Schwiebert presented the Tentative Agreement between the California School Employees Association, Local 641 and the Cambrian School District.

ACTION: On a motion by Trustee Erickson, seconded by Trustee Villalobos, the Board approved the AB 1200 Disclosure of Collective Bargaining Agreements and the tentative agreement between California State Employees' Association, Local 641 and the Cambrian School District through June 30, 2025. Motion **CARRIED** 4-0

9.11 Personnel: Compensation and Adjustment for Management, Confidential, and Classified Non-Represented Employees' Salary Schedules 2024-25: Superintendent Schwiebert presented the salary schedules for Management, Confidential, and Classified Non-Represented Employees' have been adjusted to align with the negotiated contracts by Cambrian District Teachers' Association (CDTA) and Cambrian School Employees' Association (CSEA).

The aligned adjustments are:

- 2% salary schedule increase effective July 1, 2024
- Increase of district contribution to benefits for up to the amount of \$14,600 Single; \$16,875 Two Party; \$21,775 Family

ACTION: On a motion by Trustee Middleton, seconded by Trustee Gillis, the Board approved the 2024-25 Salary Schedules for Management, Confidential, and Classified Non-Represented Employees. Motion **CARRIED** 4-0

9.12 <u>Employment Agreement: Chief Financial Officer - Third Contract Amendment:</u> Superintendent Schwiebert presented the contract amendment for Chief Financial Officer, Dr. John Pappalardo.

The contract amendment has been updated to reflect:

- An extension to the contract term by one (1) year and now ends on June 30, 2026
- An adjustment in base compensation to reflect the 2% increase provided to all employees, effective July 1, 2024
- An increase to the District's contribution for up to the amount of \$14,600 Single; \$16,875 Two Party; \$21,775 Family of benefits granted to other certificated management, to be effective July 1, 2024

ACTION: On a motion by Trustee Erickson, seconded by Trustee Villalobos, the Board approved the third amendment to the Chief Financial Officer's Employment Agreement. Motion **CARRIED** 4-0

9.13 <u>Employment Agreement: Superintendent - Third Contract Amendment</u>: President Middleton summarized the proposed amendment to the Superintendent's employment agreement.

The terms of the amendment include:

- An extension to the contract term by one (1) year and now ends on June 30, 2028
- An adjustment in base compensation to reflect the 2% increase provided to all employees, effective July 1, 2024
- An increase to the District's contribution for up to the amount of \$14,600 Single; \$16,875 Two Party; \$21,775 Family of benefits granted to other certificated management, to be effective July 1, 2024

ACTION: On a motion by Trustee Gillis, seconded by Trustee Erickson, the Board approved the third amendment to the Superintendent's Employment Agreement. Motion **CARRIED** 4-0

9.14 <u>Facilitates: Additional Classrooms at Steindorf Update</u>: Dr. John Pappalardo, Chief Financial Officer, shared the two submitted bids for the addition of two modular classrooms at Steindorf and recommend the Board reject the two bids due to the bids being significantly over the estimated cost. The Architect will adjust the plans in an attempt to reduce the costs.

ACTION: On a motion by Trustee Villalobos, seconded by Trustee Erickson, the Board rejected all bids for the two modular classrooms (Increment #1 and #2) at Steindorf K-8 STEAM School Cambrian School District; FA Project No. 23058. Motion **CARRIED** 4-0
