10. INFORMATION AND STUDY ITEM

10.1 <u>Demographics and Enrollment Projection Study Proposal</u>: Dr. John Pappalardo, Chief Financial Officer, presented the proposal for SchoolWorks Inc. to conduct a Demographics and Enrollment Projection study. The study will help ensure the District's school facilities are able to accommodate and support its current and future enrollment by utilizing existing enrollment, cohort survival factors, birth rates, and residential development for the student projections.

ACTION: On a motion by Mrs. Gillis, seconded by Mr. Rocha, the Board approved the contract agreement with SchoolWorks Inc. in the amount of \$8,500 to conduct a Demographics and Enrollment Projection study. Motion **CARRIED** 4-0

- 10.2 <u>Measure R and Measure G: General Obligation Bond Update</u>: Lori Raineri and Rich Malone, from Government Financial Strategies, presented an overview of the process and the sale results for both Measure R and Measure G.
 - Measure R: The District received seven bids and winning underwriter was Mesirow with a true interest cost of 4.17%.
 - Measure G: The District received four bids for and winning underwriter was Wells Fargo with a true interest cost of 1.94%.
- 10.3 <u>Measure R: Change Orders 3B, 3E-G, and 4C Phase 1 Modernization Projects</u>: Cheryl Demeyer from RGM Kramer presented the change orders in connection with the Phase 1 Modernization Project to replace the aging HVAC systems at Bagby, Fammatre, Farnham, Sartorette, and Price Middle School.

ACTION: On a motion by Mrs. Gillis, seconded by Mr. Middleton, the Board ratified the five (5) necessary change orders 3B, 3E-G, and 4C, in connection with the Phase 1 Modernization Projects. Motion **CARRIED** 4-0

Measure R: Geotechnical and Geologic Hazards Investigation - Modular Classrooms at Fammatre, Farnham, Price, and Sartorette: Cheryl Demeyer, from RGM Kramer, presented the agreement with Clearly Consultants, Inc. to explore the soil and foundation conditions in the general location of the planned new modular buildings and to develop recommendations for the geotechnical engineering aspects of the project designs.

ACTION: On a motion by Mr. Rocha, seconded by Mr. Middleton, the Board approved the individual service agreements with Clearly Consultants, Inc., with an estimated cost of \$32,600 per site, to explore the soil and foundation conditions at Fammatre, Farnham, Price, and Sartorette, in preparation of the new modular buildings. 10.5 Resolution 22-23-02: Declaring The Futility of Public Bidding for Plumbing Trade Services for Phase 1

Modernizations at Farnham and Sartorette Elementary Schools: Cheryl Demeyer, from RGM Kramer,
presented the resolution. The resolution will allow the District to continue with Stephen Ciari Plumbing &
Heating to complete the current project in process with the 10.26% increase over the original contracted
amount due to unforeseen project complications.

ACTION: On a motion by Mrs. Gillis, seconded by Mr. Middleton, the Board approved Resolution 22-23-02 and allow Cambrian to continue working with Stephen Ciari Plumbing & Heating to complete the Plumbing Trade Services for Phase 1 Modernizations at Farnham and Sartorette Elementary Schools. 10.6 Resolution 22-23-03: Declaring The Futility of Public Bidding for Plumbing Trade Services for Phase 1

Modernizations at Bagby Elementary School, Fammatre Elementary School, and Price Middle School:
Cheryl Demeyer, from RGM Kramer, presented the resolution. The resolution will allow the District to
continue with MBS Engineering to complete the current project in process with the 13% increase over the
original contracted amount due to the gas lines needing to be significantly rerouted unforeseen underground
utilities and tree root systems.

ACTION: On a motion by Mrs. Gillis, seconded by Mr. Rocha, the Board approved Resolution 22-23-03 and allow Cambrian to continue working with MBS Engineering and complete the Plumbing Trade Services for Phase 1 Modernizations at Bagby Elementary School, Fammatre Elementary School, and Price Middle School. Motion **CARRIED** 4-0
