Supplemental Programs & Services

- Instructional coaching and professional development for staff
- Academic support – during school hours, before/after school, intersession, summer school
- Additional enrichment learning opportunities
- Additional academic support during regular day - Push in/Pull-out individual and/or small group instruction
- Additional mental health & counseling services
- Supplemental learning curriculum/materials
- Personnel costs for crisis intervention, family support, academic intervention
- Services that address barriers to learning – homelessness, language, foster youth, economically disadvantaged students
