10.1 <u>Facilities: Energy Conservation Measures Scope of Work - Phase Two: Solar:</u> Mr. Brooklyn Stewart, Centrica Business Solutions Services, Inc., presented the scope of work for Phase Two additional solar panels at Bagby, District Office, Fammatre, Price, Sartorette, and Steindorf STEAM to help Cambrian conserve energy and save money. No action was taken.

10.2 Measure R: Award General Trade Contract for Phase 3 - Interior Classroom Modernization Projects at Bagby, Fammatre, Farnham, Price, and Sartorette: Ms. Cheryl Demeyer from Cumming Group, presented the four (4) different construction trade bid packages for the Interior Classroom Modernization Projects at Bagby, Fammatre, Farnham, Price, and Sartorette.

- 10.6 <u>Cambrian Extended Day Update</u>: Ms. Christina Bingham, Extended Care Program Coordinator, and the site supervising team shared that Cambrian's Extended Day just celebrated their 5th year and enrollment is continuing to grow. They highlighted some events from last summer's Camp Cambrian STEAM Adventure, gave an overview of the Extended Day Program, and about the positive financial impact the program is having on the district.
- 10.7 Educational Services: 2024 California Dashboard Performance Summary: Mr. Linh Nguyen, Assistant Superintendent of Educational Services, provided a quick summary of the Dashboard's purpose and the State and Local Indicators performance levels. He also gave an overview of the district's overall performance across multiple indicators and what our next steps are to continue to meet the State's priority areas.
- 10.8 Contract Agreement: Redevelopment of District Property (Phase VIII) Terra Realty Advisors: Chief Financial Officer, Dr. John Pappalardo, presented the contract with Terra Realty Advisors. The Phase VIII contract proposed here continues the work on Metzler A, additional consulting support for potential negotiations necessary for property in the "North 40 Phase II" project which encompasses land development within the Cambrian School District boundaries, and other potential developers within the district boundaries.

ACTION: On a motion by Trustee Erickson, seconded by Trustee Middleton, the Board approved the Phase VIII contract with Terra Realty Advisors to further the work on redevelopment of District Property. Motion **CARRIED** 5-0

10.9 Measure BB: Resolution 24-25-06 - Declaring the Results of the Measure BB Election and Requesting Santa Clara County to Continue to Include the Parcel Tax: Dr. John Pappalardo, Chief Financial Officer, presented Resolution 24-25-06. The resolution officially declares the results of the Measure BB election and requests the County Treasurer to continue to enroll the parcel tax on the tax roll.

ACTION: On a motion by Trustee Erickson, seconded by Trustee Gillis the Board approved Resolution 24-25-06 and declare the results of the Measure BB election and request Santa Clara County to continue to include the parcel tax. Motion **CARRIED** 5-0

10.10 <u>Budget: 2023-24 Audited Financial Statements</u>: Paul Pham from Chavan & Associates, LLP, shared the audited financial statements for the 2023-24 fiscal year. The purpose of the audit was to provide an objective independent examination of the district's financial statements. The report included aspects of the district's financial statements and whether they are presented accurately and fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. Cambrian School District had no deficiencies and a clean audit.

ACTION: On a motion by Trustee Presunka, seconded by Trustee Villalobos, the Board accepted the audited financial statements for the 2023-24 fiscal year. Motion **CARRIED** 5-0

10.11 <u>Budget: Wells Fargo Investments</u>: Chief Financial Officer, Dr. John Pappalardo, shared that after 25 years of working with Wells Fargo they will no longer be able to do business with us due to their new minimum limit of \$10 million for municipal clients as of April 1st, 2025. Cambrian would like to utilize a mixture of Delaware Statutory Trusts (DSTs) and deeds of trust as the investment tool for the funds currently held by Wells Fargo Advisors.

ACTION: On a motion by Trustee Middleton, seconded by Trustee Villalobos, the Board approved utilizing a mixture of Delaware Statutory Trusts and deeds of trust as the investment tool for the funds currently held by Wells Fargo Advisors. Motion **CARRIED** 5-0
