11. PUBLIC COMMENTS

Karen Sauer, a Steindorf grandparent, expressed her concerns regarding the breakdown of the district's vision for safety. She asked the district to take a proactive stance in evaluating what goes on at each school site.

Tiffani Tierney, a Steindorf parent, shared her concern regarding handling bullying at Steindorf and asked the board to reflect on how the situation was handled and ensure that no other student feels unsafe at school.

Stacey Bibo, a Cambrian Teacher, voiced that students' needs have changed and they need more support than ever. She shared about the three administrators' positive impact on staff and students at Price Middle School.

12.1 <u>Property Redevelopment: Exchange and Joint Escrow Agreement with Silverado San Jose, Inc - Metzler A - Fourth Amendment</u>: Dr. John Pappalardo, Chief Financial Officer, presented the fourth amendment to the Exchange Agreement with Silverado Memory Care to extend the closing of escrow from January 31, 2025, to on or before May 31, 2025, due the approval from the City of San Jose Planning Commission
