10. INFORMATION AND STUDY ITEM

- 10.1 <u>Cambrian Extended Day Update</u>: Ms. Christina Bingham, Extended Care Program Coordinator, shared that Cambrian's Extended Day just celebrated their 4th year and enrollment is continuing to grow. She highlighted some events from last summer's Camp Cambrian STEAM Adventure and the summer Accelerated Learning Program held at Steindorf. Ms. Bingham also gave an overview of the Extended Day Program's progression and next steps on the upcoming summer opportunities.
- 10.2 <u>English Learner Program Update</u>: Mr. Linh Nguyen, Assistant Superintendent of Educational Services, provided an update on the English Learner Program. He reviewed Cambrian's goals, the identification process, and the services offered. Mr. Nguyen also highlighted the programs overall achievement for the 373 English Learner students.
- 10.3 Contract Agreement: Redevelopment of District Property (Phase VII) Terra Realty Advisors: Chief Financial Officer, Dr. John Pappalardo, presented the contract with Terra Realty Advisors. The proposed Phase VII contract includes the continued work on Metzler A & Metzler C, and the Firehouse, and adds additional consulting support for potential negotiations necessary for property in the "North 40" project which encompasses a portion of land development within the Cambrian School District boundaries.
