10. INFORMATION AND STUDY ITEM

- 10.1 Communication Plan Update 2023-24: Mrs. Dawn Klavon, Coordinator of Marketing, Communication, and Community Engagement, gave an overview of Cambrian's Communication Plan and accomplishments for the 2023-24 school year. She shared how the District and school sites celebrate student success and the different ways Cambrian families are kept informed on what is transpiring in the Cambrian School Community.
- 10.2 <u>Measure R: Change Orders 4 and 3E Modular Classroom Projects</u>: Ms. Cheryl Demeyer from Cumming Group (formally RGMK), presented the change orders in connection with the replacement the oldest portables located at Fammatre, Farnham, Sartorette, and Price Middle School.

- 10.3 Measure H: Opinion Result Results: Dr. Tim McLarney, True North President, presented the results of the Measure H Feasibly Survey. He reviewed the purpose, how it was conducted, methodology of the study and reviewed questions that were asked of participants and potential next steps. In conclusion, Dr. McLarney stated that improving the quality of education is the most important issue facing our community and with initial reasonability that the Measure H parcel tax would have strong support of continuing in the Cambrian School District on the November 2024 election.
- 10.4 <u>Health and Wellness: Child Nutrition Program Update for 2023-24</u>: Sodexo representatives, Mr. Chris Battaglia and Mrs. Maria Escobar, presented an update on the District's Food Service program. They walked through the meal count comparison spanning over the last five years and announced that California will be extending the Universal Free Meals for the 2024-25 school year. The team also shared that they are continuing to make more foods from scratch and highlighted the equipment that was purchased through grants.

- 10.5 2024-25 Local Control Accountability Plan Presentations for Fammatre, Sartorette, and Steindorf: Mrs. Samantha Haley, Fammatre Principal, Mrs. Debbie Stein, Sartorette Principal, and Ms. Lisa MacFarland, Steindorf Principal, provided a summary and outline of their 2024-25 Local Control Accountability Plans. The updates included the actions and services to support; Student Academic Achievement; Effective Leadership, Teaching, and Learning; Safe School Climate, Culture, and Learning Environment; and Strong Family & Community Engagement as it relates to their respective school sites.
- 10.6 Resolution 23-24-10: Order of Election, Specifications of the Election Order and Consolidation Request: A Biennial Governing Board Member Election has been ordered to be held on Tuesday, November 5, 2024, in the Cambrian School District for the purpose of electing two (2) members of the Governing Board. The resolution allows the Governing Board to request the Board of Supervisors of Santa Clara County to call for a general election and to request consolidation and performance of services.
